<b>Endonuclease Activity (Nicked Double-Stranded DNA)</b> A 50 µl reaction in NEBuffer 4 supplemented with 1 mM ATP containing 1 µg of nicked PhiX174 RF II DNA and a minimum of 50 units of Exonuclease V (RecBCD) incubated for 4 hours at 37°C results in <10% loss in PhiX174 RF II DNA as determined by agarose gel electrophoresis. A 10 µl reaction in NEBuffer 4 containing 40 ng of a 300 base single-stranded RNA and a minimum of 10 units of Exonuclease V (RecBCD) is incubated at 37°C. After incubation for 4 hours, >90% of the substrate RNA remains intact as determined by gel electrophoresis using fluorescent detection.
